3. Wonderful Winds reserves the right to cancel any course. In the unlikely event of this happening, a full refund will be given in full and final settlement.
4. Your place on a workshop will be guaranteed once we are in receipt of your fee.
5. If the client withdraws from a workshop before the 31<sup>st</sup> July 2017 50% of the fee will be refunded. After this date no refunds will be given.
6. Wonderful Winds will provide all music.
7. Wonderful Winds cannot accept liability for death or personal injuries except for those resulting from negligence or a breach of duty.
8. Wonderful Winds cannot accept responsibility for any damage to participant's belongings, instruments and equipment except where negligence or a breach of duty has occurred.
